Mare Owner of the above Horse agrees to the following provisions:

1. Pay all boarding and other expenses monthly. Horses will not be released until such time as all fees, veterinary expenses, board bills and other charges incurred have been paid to Rockin Z Ranch, LLC in full.
2. Allow Veterinarian to examine the horse and to perform any veterinary services deemed necessary. Mare Owner agrees to pay such services.
3. Rockin Z Ranch will not be held liable for any disease, accident, sickness or death of above Horse. Rockin Z Ranch will exercise their best judgment in supervision and caring for all horses on the premises.
4. All accounts are payable within 30 days of billing date. After 30 days from billing date, interest of 1.5% per month will be accessed on the outstanding balance. Rockin Z Ranch reserves the right to refuse service when the Mare Owner's account is past due. The Mare Owner agrees to pay all reasonable attorney fees incurred by Rockin Z Ranch in attempting to collect any outstanding balances. The Mare Owner grants and acknowledges the lien right of Rockin Z Ranch pursuant to relevant federal and Oklahoma laws, particularly Title 4 O.S. ss 191 et seq. as amended and C.R.S. 38-20-102 (1) a et seq. as amended.
5. (a) Mare Owner is responsible for all registry rules, regulations and paperwork. Rockin Z Ranch assumes no responsibility in this regard.
(b) Mare Owner is responsible for all fees due to the Stallion Farm where the Stallion is standing.
(c) Mare Owner is responsible for all fees that are incurred by Rockin Z Ranch such as shipping and container charges.
(d) Rockin Z Ranch agrees to diligently try to get the above Horse in foal; however, if for any reason she does not get in foal, the Mare Owner will hold Rockin Z Ranch harmless.
6. Charges will be incurred at the following rates:
 \$16.00 per day Paddock: dry
 \$18.00 per day Paddock: wet
 \$21.00 per day Stall with outside run: dry
 \$23.00 per day Stall with outside run: wet
 \$345.00 Foaling Fee
7. Warrants and guarantees that as Mare Owner, the undersigned has full authority to enter unto this contract and is the party responsible for all terms and conditions hereof, including prompt payment of all charges.
8. When Mare Owner or authorized representative signs and returns this contract to Rockin Z Ranch it will then be a binding contract on both parties, subject to the above terms and conditions.
